

**Details for KLEU-AIET-2010 Counseling for PG Courses in the faculties of Pharmacy, Physiotherapy and Nursing:**

- 1. Those of the candidates whose results of qualifying examinations were not declared at the time of applying for entrance exam need to produce marks cards of their qualifying examination either at the time of appearing for 1<sup>st</sup> round of counseling scheduled from 7<sup>th</sup> July- 9<sup>th</sup> July 2010 or before 5:00 PM on 24<sup>th</sup> July 2010, otherwise their provisional admission shall stand cancelled and the vacancy will be included for 2<sup>nd</sup> round of counseling to be held on 27<sup>th</sup> July 2010 for allotment to the waitlisted candidates.**
- 2. For such candidates, whose results have not been declared, allotment of a seat in respective courses, irrespective of their rank in KLEU-AIET-2010, will be provisional and subject to their fulfilling the minimum eligibility criteria as determined by the University in accordance with the Rules and Regulations framed by respective Regulating Councils, displayed on the University website and submission of their marks card on or before 24<sup>th</sup> July 2010 as specified above.**
- 3. Eligibility fee for all Post-graduate courses will be Rs. 2000/-.**
- 4. The 1<sup>st</sup> round of counseling will be conducted as follows:**
  - a. Counseling for M. Pharm will be from 7<sup>th</sup> July to 9<sup>th</sup> July 2010 in B.S. Jirge Auditorium at University campus.**
  - b. Counseling for M.Sc. (Nursing), and MPT courses will be conducted on 7<sup>th</sup> July 2010 in the anatomy lecture hall of J. N. Medical College, Belgaum.**

5. There shall be **no subject-wise waiting list in any of the faculties (Pharmacy, Nursing and Physiotherapy).**
6. **Total 400 wait-list numbers** will be allotted for **M. Pharm.** during the 1<sup>st</sup> round of counseling in the **General category** and there shall be separate **waitlist for BRD category** having **25** numbers. **For MPT and M.Sc. (Nursing)** the number of waitlists shall be **20 in each of the faculty in General category.** Under **BRD category 05 and 02** wait list numbers shall be allotted for **MPT, and M.Sc. (Nursing) under BRD category.**
7. **The 2<sup>nd</sup> round of counseling will be on 27<sup>th</sup> July 2010** for allotment to the **waitlisted candidates.** Those of the candidates whose allotted seat have been cancelled and included for 2<sup>nd</sup> round of counseling, because result of their qualifying exam were not declared by 24<sup>th</sup> July 2010, **will also be eligible to attend 2<sup>nd</sup> round of counseling if they produce marks card of their qualifying exam on the day of 2<sup>nd</sup> counseling.** Such candidates will be called for counseling according to their rank obtained in inter-se merit of KLEU-AIET-2010.
8. Those of the candidates desirous of keeping their name in waiting list for **M. Pharm, MPT, and M.Sc. (Nursing)** have to mandatorily deposit the Demand draft for a minimum amount of **Rs. 50,000/- (Rs. Fifty thousand only)** with the University.
9. As there are no applications under KTC category in any of the Post-graduate courses, the seats reserved under KTC category shall be transferred to BRD category.

If there is no eligible candidate under **BRD category** the vacant seat will be transferred to **General Merit category**.

**10.** The Demand draft for paying tuition fee has to be purchased by the candidate or his parent. In case the demand draft has been purchased by any other person, necessary undertaking / declaration has to be submitted as per the proforma provided by the University.

**11.** If a candidate is not able to attend the counseling and represented by his parent / guardian, then the candidate has to appear for Biometric analysis and Photo Identification within 72 hours of the allotment of the seat. However if the representative has opted only waitlist number then the physical presence of the candidate is must on the date as notified by the University for Biometric verification and Photo Identification.

**12. All courses commences from 15<sup>th</sup> July 2010.**

**13.** A candidate, who has been **allotted a seat in the 1<sup>st</sup> round of counseling, must join the course by 5: 00 PM on 24<sup>th</sup> July 2010**, depositing original documents and Demand Draft for the fee, failing which, the seat allotted shall stand cancelled, and the vacancy will be included for 2<sup>nd</sup> round of counseling to be held on **27<sup>th</sup> July 2010** for allotment to the **waitlisted candidates**.

A candidate, who has been **allotted a seat in the 2<sup>nd</sup> round of Counseling, must join the course immediately on the same day before 5: 00 PM failing which the allotted seat stands cancelled.**

**14.** Original documents will not be given back to candidates after 2<sup>nd</sup> counseling. If a candidate wishes to take back their original documents after 2<sup>nd</sup> counseling, shall do so by surrendering the seat allotted to him/ her.

**15. There shall be no 3<sup>rd</sup> round of Counseling.** The vacancies arising after the second counseling shall be notified on the University website and allotment shall be made based on the waitlist numbers called in chronological order.

**16. Refund Policy: (a).** If a student submits his / her application for **cancellation of allotted /confirmed seat** in the prescribed form duly completed **before 5:00 PM on 31<sup>st</sup> July 2010**, there will be no deduction from tuition fee. Only Rs. 1000/- (Rs. One thousand only) will be deducted as processing charges.

**16.(b).** If a student submits his / her application for **cancellation of allotted /confirmed seat** in the prescribed form duly completed, after **5:00 PM on 31<sup>st</sup> July 2010 but before 5:00 PM on 31<sup>st</sup> August 2010**, his / her **proportionate tuition fees will be deducted in addition to Rs.1,000/- (processing charges)** and remaining amount will be refunded from the tuition fees paid.

**16. (c).** If a student submits his / her application for **cancellation of allotted /confirmed seat** in the prescribed form duly completed, after **5:00 PM on 31<sup>st</sup> August 2010**, the candidate has to pay the tuition fee for entire duration of the said course.
