Other terms and conditions:

- (i) The Research Scholars shall strictly adhere to the Rules and Regulations of Ph.D. Program of the University which are in existence and framed from time to time.
- (ii) The Research Scholars shall bear all expenses by themselves towards conduct of the study for research work. The available physical infrastructure and library facility of the University can be used for the research work.
- (iii) The Research Scholars shall not register for any other academic program of Indian / Foreign University during the period of Ph.D. program.
- (iv) The Research Scholars shall attend all the seminars and orientation programs to be conducted by the University/Departments relating to their research topic / project. A separate log book needs to be maintained by all the Research Scholars and the same should be made available as and when required by the University.
- (v) The internal candidates (those working in KLE Institutions) are required to give an Undertaking to the effect that they shall serve the KLE Institution at least for a minimum period of three years after the completion of their Ph.D. Programs.
- (vi) The Research Scholars shall not discontinue the Ph.D. Program during the course period. However, in case the Research Scholars discontinue the program, their registration gets cancelled and such Research Scholars are liable to pay the entire course fee.

- (vii) The internal candidates (working in KLE Institutions) who leave the Institution after successful completion of Pre-Ph.D. Examination, the University will permit them as Research Scholars on Part-Time basis subject to condition that the Research Supervisor (Guide) is from the same place and also payment of entire fee by such candidates as applicable for Full-Time Research Scholars.
- (viii) The Full-Time Research Scholars who receive financial assistance (monthly stipend & contingency) from the University, on discontinuation of the Ph.D. Program shall refund the entire financial assistance granted to them.
